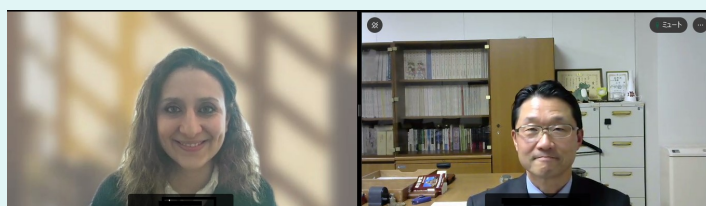
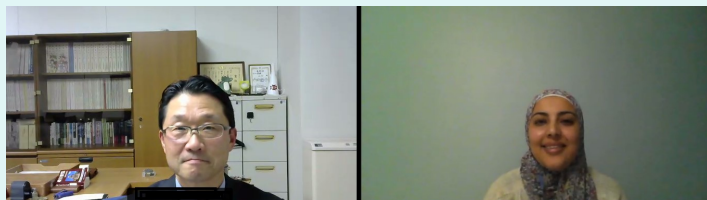
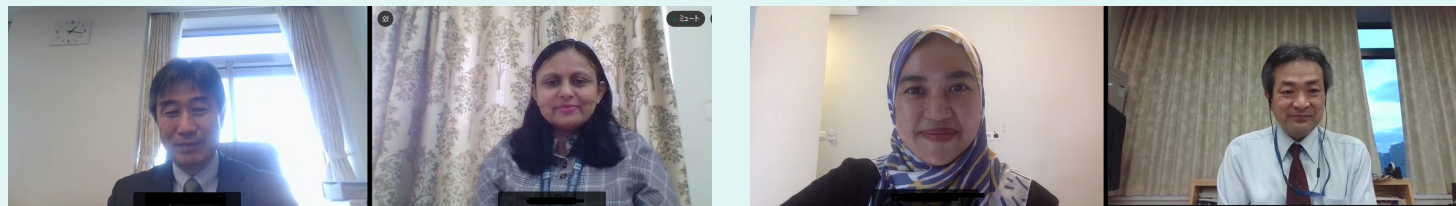

Greetings with Senior Officials of the JFSA

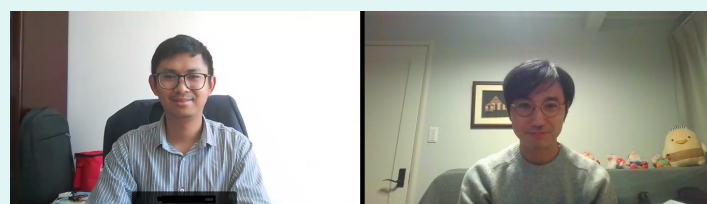
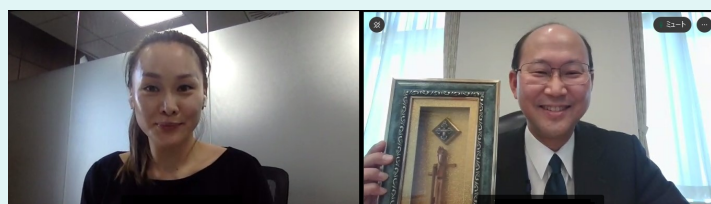
