## 18th Group of the GLOPAC - 10 Visiting Fellows from Securities Authorities

### GLOPAC Virtual Fellowship Program

The GLOPAC invites officials of financial regulatory authorities in emerging countries and regions physically to Tokyo, Japan, for the Fellowship Program for 2-3 months; however, we have conducted the Program virtually due to the global spread of Covid-19. The very first virtual Fellowship Program was completed in January 2021, and the 18th Group of the

Program was also conducted virtually, from February to June 2021. The Program was divided into 2 phases, and we looked for an opportunity to conduct phase 2 on a face-to-face basis, but, unfortunately, the global situation of Covid-19 had not improved enough to invite the Fellows to Japan. The face-to-face Program is, of course, effective and ideal, but we should make use of the digital technology amid the pandemic, and this is how we continue the Program.

This time, as the GLOPAC 18th group, we welcomed 10 officials from Cambodia, India, Indonesia, Kenya, Laos, Mongolia, Myanmar, Nepal, Thailand and Vietnam, and there was a 6-hour time difference at most between Japan and Kenya among the Fellows. An early afternoon in Japan meant an early morning in Kenya! We are proud that the Fellow from Kenya showed a strong intention to learn from the Program and actually did a great job throughout it. I think I don't need to mention that the other Fellows also did a great job!
