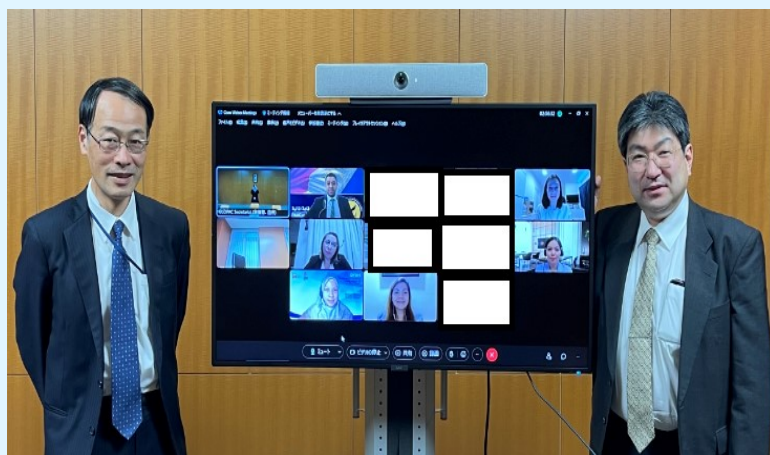

GLOPAC Virtual Fellowship Program

The 20th GLOPAC Fellowship Program was conducted from February to June 2022 on an online basis, and 10 officials from securities supervisory authorities successfully completed it. The Program was divided into 2 phases, and we looked

for an opportunity to conduct phase 2 on a face-to-face basis; however, unfortunately, the situation of Covid-19 had not eased enough to invite the Fellows to Japan and this was the 4th time that we conducted fully online training. A face-to-face Program would, of course, be more effective and ideal, but we believe that the participants have learned as much as they would have been able to learn from a face-to-face program due to their active participation. However, please do not forget that a physical visit will be arranged in the future after all travel restrictions are lifted! As the 20th GLOPAC group, we welcomed 10 officials in total from Argentina, India, Indonesia, Egypt, Saudi Arabia, Thailand, Philippines, Vietnam, Malaysia and Mongolia. This was the first time for us to welcome officials from Argentina and Saudi Arabia to the securities program. 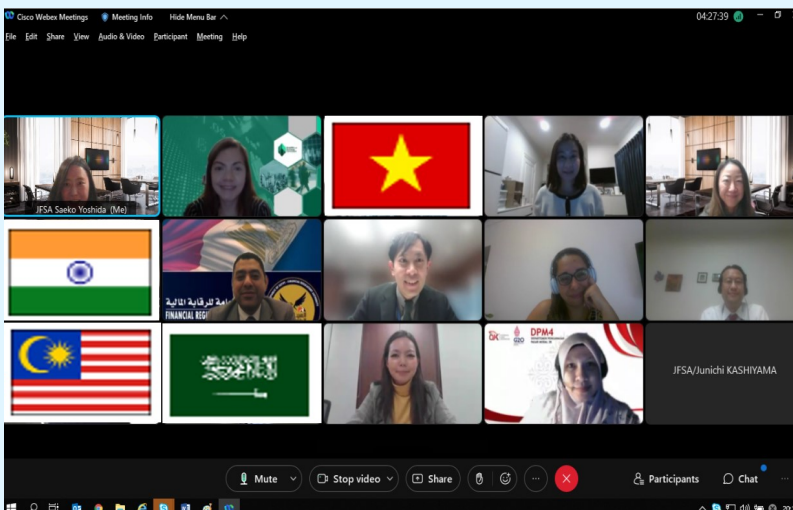

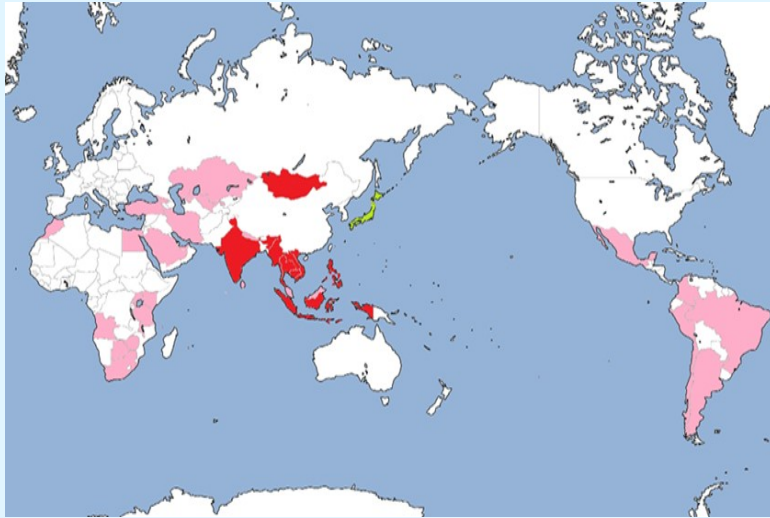
