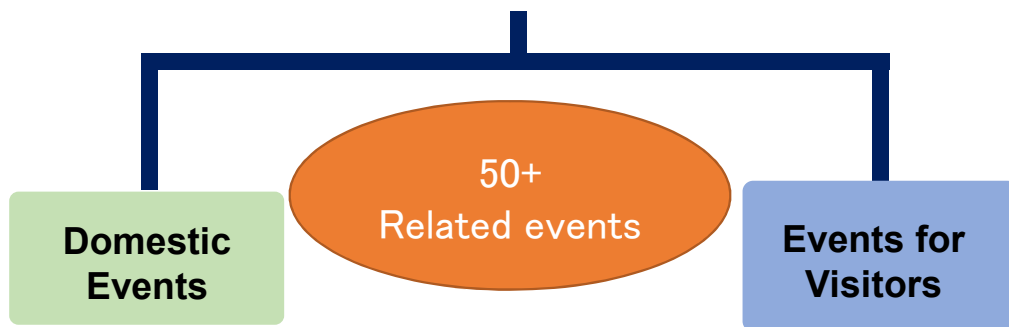

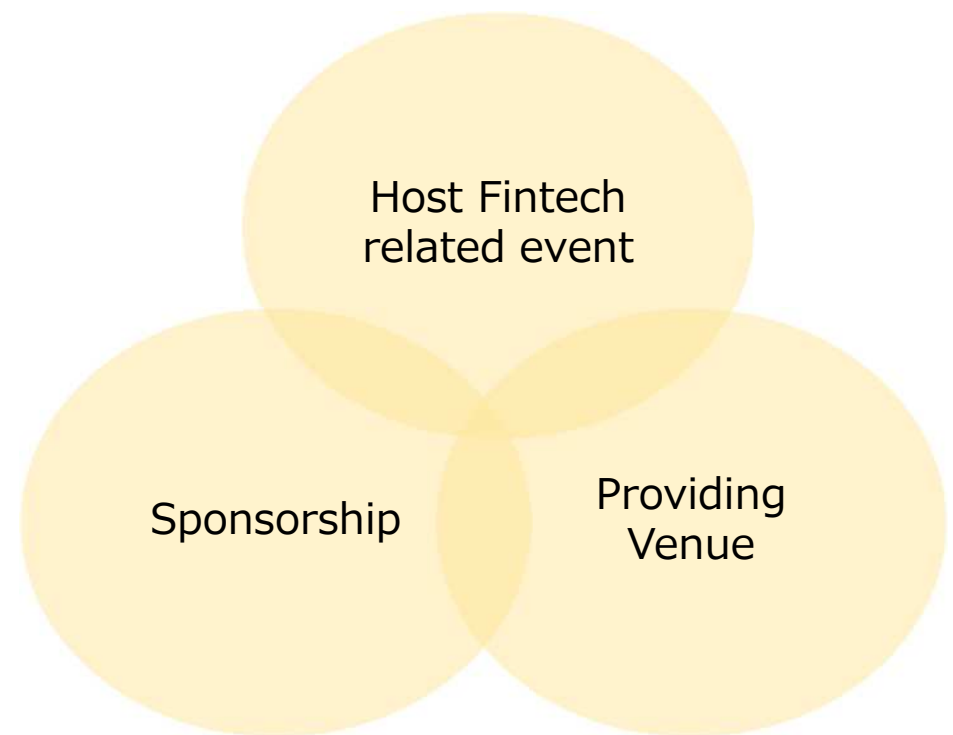



Applying for JFW2025 related events

✓ About certification criteria

- With the cooperation of local governments, industry associations, fintech-related startups, and other related parties, a total of 49 side events were held during Japan Fintech Week (JFW) 2024.
- We would like to establish criteria for certification as a cooperative event to support the success management of your event.

JFW criteria for certification	
1	The scope of the organizer must be one of the following, and must be trustworthy to the organizer and related parties. 1 National Administrative Organizations 2 Local public body 3 Non-profit organizations such as public interest corporations or their equivalents 4 Newspapers, radio and television companies, and other media organizations 5 Financial businesses 6 Other organization deemed equivalent to the above
2	Those whose business purpose is recognized as actively contributing to the promotion, dissemination, or enlightenment of the administration under the jurisdiction of the Financial Services Agency.
3	The business contributes to the improvement of life or culture of the general public and is not for profit.
4	In cases where there are two or more speakers or speakers for the project, the organizer is deemed to have made efforts to ensure that there is no bias in the gender of the speakers or speakers.

Cooperation after qualifying as a JFW related event

1. Using the JFW2025 logo
2. Posting your events on our JFW special website
3. Posting your events on FSA's SNS (X or LinkedIn)
4. Promote you events on our JFW newsletter
5. Invitation to JFW Reception (Possibility of limiting the number of people)
6. List your events to online matching service (※TBD)
7. Invitation to communication tool for organizers (※TBD)
8. Arrange FSA executive speaker participation



Compliance items after qualifying as a JFW related event

1. Prohibition of excessive advertising of products and services.

Please do not excessively promote the specific products or services of the organizers' or sponsors' so as not to mislead participants into believing that FSA is endorsing a particular product or service.

2. When considering obtaining sponsors to cover expenses related to the event, the selection of sponsors should be done strictly, including the exclusion of antisocial forces and unregistered businesses.

3. Submit income/expenditure plans and performance reports as required.

4. Use the JFW logo on the event's website and at the event site to indicate that it is a JFW-related event.

5. Please take sufficient measures to prevent accidents and to ensure public health when holding an event.

6. Please submit a request at least 20 business days prior to the event if you wish to have an FSA executive participate or speak at the event.

7. If there will be government officials or other speakers, please notify us at least 10 business days prior to the event date.

8. The number of participants must be counted and reported to the JFW organizers within 10 business days after the event.
